## BYLAW 466-18 OF THE VILLAGE OF GLENDON

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF GLENDON FOR THE 2018 TAXATION YEAR.

Whereas, the Village of Glendon has prepared and adopted detailed estimates of the municipal revenue and expenditures as required, at the Council meeting held on May 17, 2018; and

Whereas, the estimated municipal expenditures and transfers set out in the budget for the Village of Glendon for 2018 total \$2,715,687.00; and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$2,175,686 and the balance of \$540,001 is to be raised by general municipal taxation; and

Whereas, the Council is authorized to classify the assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26, Revised Statutes of Alberta, 2000; and

Whereas, the assessed value of all property in the Village of Glendon as shown on the assessment roll is:

**Now therefore,** under the authority of the Municipal Government Act, the Council of the Village of Glendon, in the Province of Alberta, enacts as follows:

That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed property as shown on the assessment roll of the Village of Glendon:
