Res: 99-26 Motioned by Mayor Papirny that the 2026 Operating and Capital Budget be approved as presented.

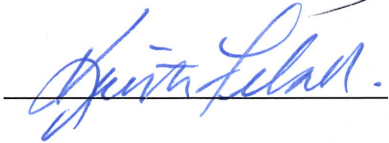
