

BYLAW NO. 380/00
Of the
Village of Glendon

A BYLAW OF THE VILLAGE OF GLENDON IN THE PROVINCE OF ALBERTA TO PROVIDE FOR THE NUMBERING OF STREETS AND LOTS IN THE VILLAGE OF GLENDON.

WHEREAS, IT IS DEEMED EXPEDIENT AND PROPER PURSUANT TO THE PROVISIONS OF section 7 of the Municipal Government Act, Chapter M-26.1 and amendment thereto, that the Council of the Village of Glendon in the Province of Alberta shall issue a bylaw to provide for the orderly numbering of streets and parcels of lands located within the corporate limits of the Village of Glendon in the Province of Alberta; and

WHEREAS, provision shall be made for the further numbering of newly created streets and parcels of land and shall require the registered property owners or occupants to display assigned numbers in approved form.

NOW THEREFORE the Municipal Council of the Village of Glendon in the Province of Alberta duly assembled enacts as follows:

1. That all Streets and Avenues, parcels of land, buildings, units and sub-units in buildings within the corporate boundaries of the Village of Glendon are hereby numbered.
2. That Streets shall generally run north and South, Avenues shall generally run East and West.
3. That all Streets and Avenues within the corporate limits of the Village of Glendon shall bear and be known, described by the Map attached as Schedule "A" and forming part of this bylaw. Furthermore, that some Streets may also be named as shown for historical or sentimental value and officially these Streets shall be referred to by that name designated at Council's leisure.
4. That each parcel of land, building, unit or sub-unit in a building shall be numbered with three, four or five digits, the first one, two or three digits shall indicate the street location (i.e. every number on 50th Street between 49th Avenue and 50th Avenue shall be prefixed by 49) and the parcel of land, building or unit or sub – unit in a building on the block.
5. That each parcel of land, building, unit, or sub-unit in a building shall include the quadrant identifier Southeast (S.E.), Northeast (N.E.), Southwest (S.W.) or Northwest (N.W.) as part of the address based on the quadrant each parcel of land, building unit or sub-unit in a building is located.
6. Numbers on parcel of land, buildings, units or sub – units in buildings located on the west and south sides of streets and avenues shall end in even numbers, while numbers on parcels of land, building, units, or sub-units in buildings located on the east and north sides of the streets and avenues shall end in odd numbers.

7. The registered property owner or occupant of the parcel of land, building, unit or sub-unit shall place the appropriate numbers in a satisfactory location approved by the Village Manager on the parcel of land, building, unit or sub-unit in a building. The numbers shall be minimum size of four inches (4") in height and of a contrasting color to the surface it is affixed to.
8. The Council of the Village of Glendon in the Province of Alberta hereby delegates to the Village Manager the authority to assign appropriate numbers on newly subdivided Streets, Avenues, Parcels of land, buildings, units or sub-units in a building. The Village Manager shall maintain a concise and accurate record of all assigned numbers.
9. Offences and Penalties
 - 9.1 A person, who contravenes any provision of this Bylaw, shall be deemed to be guilty of an infraction of the Bylaw and upon a conviction, is liable to a fine of not less than \$250.00 and not more than \$2,500.00. No person found guilty of an offence under this Bylaw shall be liable to imprisonment.
 - 9.2 A Peace Officer or Bylaw Officer is hereby authorized and empowered to issue a Violation Tag to any Person who the Peace Officer or Bylaw Officer has reasonable and probable grounds to believe has contravened any provision of this By-law.
 - 9.3 A Violation Tag may be issued to such Person:
 - a) either personally, or
 - b) by mailing a copy to such person at his last known post office address.
 - 9.4 Where a contravention of this By-law is of a continuing nature, each calendar day constitutes a new and separate additional offence.
 - 9.5 Where a Violation Tag is issued pursuant to this By-law the Persons to whom the Violation Tag is issued may, in lieu of being prosecuted for the offence, pay to the Village of Glendon the specified penalty of \$100.00.
 - 9.6 Nothing in this By-law shall prevent a Peace Officer or By-law Officer from issuing a Violation Ticket for the mandatory Court appearance of any Person who contravenes any provision of this By-law.
- 10 Violation Ticket
 - 10.1 If the penalty specified on a Violation Tag is not paid within the prescribed time period, then a Peace Officer is hereby authorized and

empowered to issue a Summons pursuant to the Provincial Offences Procedure Act, S.A. 1988, c.P-21.5.


10.2 Notwithstanding Section 9.1 of the By-law, a Peace Officer is hereby authorized and empowered to immediately issue a Summons pursuant to Part 11 of the Provincial Offences Procedure Act, S.A. 1988, c.P21.5, as amended, to any person who the Peace Officer has reasonable grounds to believe has contravened any provision of this By-law.

11 This Bylaw shall come into full force and effect with the third and final reading of this bylaw.
