**BY-LAW NO. 405-09  
OF THE  
VILLAGE OF GLENDON**

**A By-Law of the Village of Glendon in the Province of Alberta, pursuant to the provisions of the Municipal Government Act, being Chapter M26, R.S.A. 2000 and amendments thereto, to provide for waste collection and disposal for Glendon residents.**

Now Therefore, under the authority and subject to the provisions of the Municipal Government Act. R.S.A. 2000, Chapter M26 as amended and by virtue of all other powers enabled, the Council of the Village of Glendon, duly assembled, enacts as follows:

**Section 1 Title**

1.1 This By-Law shall be known as a waste disposal and collection By-Law.

**Section 2 Purpose**

2.1 To provide regulations and rates as it pertains to waste collection and disposal.

**Section 3 Definitions**

3.1 "Act" means the Municipal Government Act, Chapter M-26, R.S.A. 2000 and amendments thereto.

3.2 "Garbage" shall mean the refuse of animal or vegetable matter which has been used for food or intended to be used, and containers containing particles of food.

3.3 "Ashes" shall mean the residue of any combustible substance used for fuel.

3.4 "Rubbish" shall mean any non-decomposing solid wastes including ash and consisting of combustible and non combustible material.

3.5 "Householder" shall mean any owner, occupant, lessee or tenant or any person in charge of any dwelling, hotel, restaurant, apartment house, office building, public institutions or other building or portion thereof.

3.6 "Collection Day" means the day or days on which waste is regularly collected from specific premises.

3.7 "Council" means the municipal Council of the Village of Glendon.

3.8 "Single Family Residential" means

- a) any building containing one dwelling unit on a tax parcel as determined from assessment records, or
- b) any permanent mobile home as determined from assessment records.

3.9 "Multi family residential" means any building containing more than one dwelling unit on a tax parcel, as determined from assessment records.

**Section 4 Collection General**

4.1 The Village shall remove garbage from single family residential dwellings once per week.

4.2 The Village shall remove garbage from multi family residential dwellings up to and including a four (4) plex once per week.



4.3 The Village shall remove garbage from commercial or industrial enterprise once per week

4.4 Every residential and commercial property shall provide a designated raised area for the garbage receptacles. All refuse receptacles must be fitted with covers that remain closed. The covers must be suitable to prevent waste from spilling or blowing from the receptacles.

4.5 A person shall place waste only in refuse receptacles located on their property.

### **Section 5 Duty of Collectors**

5.1 Collectors shall be as careful as is reasonably possible not to damage or misuse any refuse receptacle.

5.2 Collectors shall replace emptied refuse receptacles and the lids in approximately the same location where picked up.

5.3 Collectors shall not leave waste which has spilled on the ground from the refuse receptacle, the containerized bin or the collection vehicle which in the process of loading.

5.4 Under no circumstance shall a Village collector enter onto personal property beyond the designated area for the collection of the waste.

### **Section 6 Preparation of Waste for Collection**

#### **Section 6 Preparation of Waste for Collection**

6.1 A person, being the owner, occupant tenant or person in charge of any building or premises shall put out or permit to be put out for collection, garbage in refuse receptacles.

6.2 A "refuse receptacle" or "receptacle" means:

1) a container of watertight, rust resistant construction, of circular design, having a smooth rim, rigid fixed handles and a watertight cover, and having the following specifications:

a) between 46 cm and 41 cm in diameter at the top, and

b) between 76 cm and 51 cm in height, and

c) between 60 and 110 litres

2) a non-returnable plastic bag, securely tied at the top when ready for collection, being no more than 76 cm in height, no more than 76 cm in height, no more than 46 cm in width and capable of holding 27 kg of contents when lifted.

6.3 The Village shall not collect garbage and take garbage from any receptacle which with the weight of its contents exceeds 27 kg.

### **Section 7 Location of Receptacles**

7.1 A person shall not place or keep or permit to be placed or kept any refuse receptacles or containerized storage bins upon any lane, street, boulevard, sidewalk or avenue of the Village.

7.2 The receptacle containing waste material for collection, shall be placed no more than ten (10) feet from the property line.

**Section 8 Burning of Waste**

A person shall not burn waste or any other material unless permission to do so has been issued by the Glendon Fire Department.

**Section 9 Waste Disposal Fee**

9.1 Customers shall pay a waste disposal fee, which will be placed on the monthly utility bill, as per the following:

Type of Dwelling Fixed Monthly Service Charge

Single Family Residential \$18.00 per unit per month

Multi Family Residential

-Duplex \$12.00 per unit per month

-Four Plex \$12.00 per unit per month

Commercial Property

- \$30.00 per month

**Section 10 Non-Compliance With By-Laws**

10.1 A person shall not deposit or permit to be deposited any type of waste on any Village highway or property.

10.2 If a person, being the owner, occupant, tenant or person in charge of any building or premises has been given an order to remedy any condition contrary to any part of this By-Law and neglects or refuses to comply with such an order within the time specified, the same may be done by the Village at the expense of the person in default. All expenses incurred shall be in addition to and not a substitute for any fines or penalties to which the person may be subject pursuant to the provisions of the By-Law. On default of payment of these expenses, the Village may recover the expenses thereof with the costs, by action or in like manner as municipal taxes.

10.3 The penalties applicable to offences under this By-Law are as follows:

1st Offence = \$100.00

2nd Offence = \$120.00


3rd Offence = \$150.00
